PANEL MEETING WELCOME

1. The Chair of the Panel welcomed all attendees to the meeting.

APOLOGIES FOR ABSENCE

2. Apologies were received from Mr A Harrold, Mr S Richards, Mrs L Beesley, Miss S Armstrong and Superintendent G House.

MINUTES AND MATTERS ARISING

- 3.1 The draft minutes of the meeting held on 19 January 2026 were approved as a true and accurate record, subject to an amendment on page one to include the two ICV names that were noted as missing.

Action: Governance Manager

- 3.2** The actions on the Action Log were discussed. Please refer to Action Log in the Panel paper pack for more detail on each action.

VISIT REPORTS

- 4.1** The Chair highlighted key data from the visits during Quarter 4 - 1 January 2026 to 1 April 2026.
- It was noted that 91% of detainees were happy to speak with the ICVs, representing an improvement on the previous quarter.
 - Of those detainees who were not spoken to, 22.5% were recorded as being asleep at the time of the visit.
 - The report demonstrated that visits had taken place across every day of the week, with all time slots covered.
 - It was noted that entry was gained within five minutes for all visits except one, and the Force was thanked for this.

Recurring Themes

- The Governance Manager provided an overview of the recurring themes, noting that four first reviews had been conducted late, although rationales continued to be reported consistently.
- It was noted that up to seven detainees had not been informed of reviews conducted during sleep, and this issue will continue to be monitored.
- In relation to late 30-minute observations, a total of seven were identified, of which four did not have a recorded rationale. Of the remaining instances, two were under ten minutes late, four were between eleven and twenty minutes late, and one observation was missing completely.

CUSTODY VISIT REPORTS

- 4.2 Weymouth – 7 January 2026 & Weymouth – 9 January 2026 - Reports 54 and 66**

The Escorting Officer 7797 had been noted having been helpful during both visits. This would be fed back.

- 4.3 Bournemouth – 16 January 2026 – Report 68 – AB & HJ**

ICVs noted that in relation to detainee 0353, the second review had been late, although a rationale had been provided. It had also highlighted that, within the initial risk assessment, the need for an Appropriate Adult (AA) had been identified; however, a strip search had been conducted without an AA present. The log had shown that an AA had been recommended by CJLD, but TAAS advised no one had been available at the time. It had been further noted that an AA subsequently arrived and had been present for the taking of intimate samples. VS will provide an update.

Action: Detention Officer VS

- 4.4 Bournemouth – 26 January 2026 – Report 70 – AM & SR**

A black African detainee had declined showering facilities in police custody, stating that showering caused black skin to dry out. It had been noted that in prison settings, appropriate moisturiser would be provided and ICVs asked whether a similar provision

could be made available within custody. The Chief Inspector would make enquiries to see if this could be accommodated.

Action: Chief Inspector Bishop

4.5 Bournemouth – 2 February 2026 – Report 74 – LT & HJ

Two matters had been noted from this visit. It had been reported that two individuals were expected into custody as 'lock outs'. Chief Inspector Bishop advised that short term "lock outs" can occur when prisons reach capacity or when prisons reception time has passed. It was noted that this is likely to happen more frequently in the future. Such cases will be recorded on Niche but not under PACE and instead identified on the whiteboard as "Lockout." ICVs were advised to continue visiting and to treat these detainees as they would any others. If this became an ongoing issue, it would be monitored and tracked.

The ICVs reported that the custody log for detainee 0743 showed TAAS were contacted at 09:37, arrived at 13:30, and rights were read at 14:27. The Custody Sergeant advised that there had been ongoing issues with delays in the attendance of AAs, which resulted in vulnerable individuals remaining in custody longer as processing and interviewing could not take place without them. The ICVs asked whether appropriate adults are still tracked for young people and vulnerable adults, and it was confirmed that both groups continue to be monitored.

4.6 Weymouth – 25 February 2026 – Report 81 – HJ & NH

During this visit ICVs identified ten vegetarian breakfast meals that were past their best before date by approximately one month. This was initially challenged by staff on the basis that the items were not out of date in terms of use by date. Following a discussion, the items were disposed of.

The ICVs visited detainee 1279 in cell M11 and noted that the hot temperature in the cell. The recorded temperature at the time was 24.5 degrees. Chief Inspector Bishop acknowledged that at times controlling the temperature in Weymouth could be challenging.

4.7 Weymouth – 11 March 2026 Report - 85 – NH & CS

In relation to detainee 1627 in cell YP2, the log indicated that PAVA had been used, but the detainee had not been offered a shower. Clarification had been sought around the correct procedure. Chief Inspector Bishop advised that either a full shower should be offered, or the detainee should attempt to blink through it. This would be investigated further and an update provided.

Action: Chief Inspector Bishop

4.8 Bournemouth – 15 March 2026 – Report 88 – CS & HJ

ICVs noted that the drawers that hold the religious tracts had been damaged and needed fixing or replacing. Detention Officer VS would check this and get back to the OPCC.

Action: Detention Officer VS

Three cells in the suite had ongoing maintenance issues and that one of the exercise yards had been out of use. Detention Officer VS advised that this had been raised to Estates, and progress would be chased.

ICVs visited detainee 1745 and noted from the custody log that there had been a delay in authorisation of their detention. It had also shown that the first review had taken place at 14:05 while the detainee had been asleep and they had not been informed of the review until 18:57. Chief Inspector Bishop advised they would be reminded of the requirement to notify detainees of reviews undertaken whilst they had been sleeping.

Action: Chief Inspector Bishop

It was noted that CJLD had recommended the detainee have an AA, however, the detainee stated they did not need one. Chief Inspector Bishop advised that the Custody Sergeant made the final decision on whether an AA would be required.

It had been noted that Niche needed updating to show child/children rather than juvenile or young person. Chief Inspector Bishop would follow this up.

Action: Chief Inspector Bishop

4.9 Bournemouth – 23 March 2026 - Report 89 – RW & SR

The ICVs reported that the religious tracts had not been stored in the correct manner. Chief Inspector Bishop stated staff would be made aware.

Action: Chief Inspector Bishop

ICVs noted a child had been in custody for an extended period and there had been delays throughout the process. Chief Inspector Bishop shared that this had been a complex case, and the child had been detained for several offences with other connected individuals, and they had to be kept apart which had caused delays.

4.10 Bournemouth – 30 March 2026 - Report 92 – JH & NH

ICVs noted that detainee 2103 had not been informed the first review had taken place. Chief Inspector Bishop acknowledged this had been a common theme and advised reminders would be issued to all staff.

Action: Chief Inspector Bishop

Chief Inspector Bishop provided an update on the recruitment of a new Custody Support Manager and thanked the ICVs for their efforts and hard work.

The chair reminded everyone of the location of the upcoming panel meetings.
