PANEL MEETING WELCOME

1. The Chair of the Panel welcomed all attendees to the meeting.

APOLOGIES FOR ABSENCE

2. Apologies were received from Mr A Bamgboye, Mrs F Maund, Mr Chris Slater and Mrs C Cullen.

MINUTES AND MATTERS ARISING

- **3.1** The draft minutes of the meeting held on 27 January 2025 were approved as a true and accurate record.
- 3.2 The Chair provided information regarding the actions on the Action Log and would circulate the document following the Panel meeting. All actions from the previous meeting had been completed.

Action: Governance Manager – share the Action Log

4.0 VISIT REPORT

- **4.1** The Chair highlighted key data from the visits during Quarter 4, 1 January 2025 to 1 April 2025.
 - Seventy-six people were visited out of the 174 who were detained. Ninety-two visits were offered in total, and sixteen detainees refused. Eighty-three percent were happy to speak with the ICVs which was positive.
 - Of the detainees that were not spoken to, 35 (38%) were asleep at the time of the visit and 16 (9.2%) refused a visit.
 - Visits were made on every day of the week with a good variety of times, achieving visits during every time slot at Weymouth and all but one at Bournemouth. The Chair thanked the visitors for their achievements.
 - The waiting time for entry into the custody suites was within five minutes for every visit this quarter, another positive result for Dorset Police. The Chair asked the Custody Manager to thank the staff.
 - The average length of visits had been between 1 and 2 hours.
 - The number of late inspector reviews had reduced this quarter from twelve down to nine, but visitors had not noted any occurrences of detainees not being informed of their review following a sleep period.
 - The number of late 30-minute observation checks had slightly increased by one, but there had been no late 60-minute observation checks recorded this quarter.

CUSTODY VISIT REPORTS

4.2 Bournemouth 8 January 2025 Report 1134

The ICVs reminded the Governance Manager to amend this visit record as one detainee had been recorded twice in error.

Action: Governance Manager – to correct recording error

4.3 Weymouth 21 January 2025 Report 1169

The ICVs had recorded a cracked tile in one of the cells. The Custody Manager advised that Health and Safety and Estates had visited the cell, risk assessed and had been decided no further action would be necessary. He added that there had not been any adverse incidents recorded.

4.4 Bournemouth 31 January 2025 Report 1183

The ICVs had waited for an hour and a half before an officer had been available to escort them. They had observed how busy the staff had been during their wait. The Governance Manager had expressed her disappointment for the delay but agreed with the Custody Manager that the care and welfare of the detainees must be the priority.

4.5 Bournemouth 18 February 2025 Report 1212

ICVs had noted from a detention log that detention had been authorised for one detainee held under PACE, but the log stated the Immigration Service had authorised further detention.

Added following the meeting: The Custody Development Officer had provided the following explanation.

If the detainee is being held under PACE for immigration purposes then the Immigration Service will authorise further detention as it is their investigation. They will become an Immigration detainee once the relevant paperwork (IS91) is served.

4.6 Weymouth 27 February 2025 Report 1235

The ICVs had reported that the Torah had been missing within the religious tracts, a new Torah and another Jewish prayer book recommended by the local Rabbi had been provided since the visit.

4.7 Bournemouth 17 March 2025 Report 1251

During this visit ICVs had noted an infestation of drain flies in the shower room which had resulted in two cells being out of use. The Custody Manager advised that the issue had been resolved and cleaning staff would regularly flush the drains to prevent any further reoccurrence.

ICVs had also recorded a further cell had been out of action due to a faulty door. The Custody Manager advised that he had met with the Head of Estates to discuss the issue, and efforts were being made to resolve the issue as soon as possible. He added that there had been no adverse incidents.

4.8 Weymouth 18 March 2025 Report 1259

Following a lengthy discussion with the Custody Sergeant, ICVs had decided not to visit a foreign national detainee who could not speak any English. The Force had already used the interpretation service to speak with the detainee and had been waiting for further contact from them. The ICVs had been keen not to upset the detainee unnecessarily as it would have been likely that he could not have understood why they were there. However, due to the vulnerability of the detainee permission was given for the ICVs to view the detention log. The ICVs asked that the custody staff be thanked for their assistance with this case.

Action: Custody Manager – share thanks from ICVs.

4.9 Weymouth 20 March 2025 Report 1263

During this visit, the Escorting Officer introduced the ICVs and used the first name of the detainee in his introduction. ICVs asked the Custody Sergeant to inform the officer that the use of names should be avoided. The Custody Manager agreed to issue a reminder to staff not to use names to keep anonymity for all.

Action: Custody Manager - issue reminder to staff.

4.10 Bournemouth 30 March 2025 Report 1276

ICVs noted that two detention logs had been mixed up between a female adult and a female juvenile creating confusion around references to Appropriate Adult attendance. This was a human error which has now been rectified.

4.11 Bournemouth 3 March 2025 Report 1286 – Paper copy added 31 March

ICVs had asked if fruit could be provided to a detainee who had been in custody for a day and a half. The Custody Manager advised that a detainee being held for under 36

hours would be offered the general meals available. If a detainee had been held for longer than 36 hours then consideration could be given to purchasing alternative provisions.

5. ANY OTHER BUSINESS

- **5.1** The Custody Manager provided the Panel with an update on custody which included the current proposals for a shift pattern change for staff.
- **5.2** The Director of Operations provided an update to the Panel on the re-commissioning of the Appropriate Adult Service.
- 5.3 An ICV asked if following the UK Supreme Court ruling regarding the 'biological sex' whether the Force had changed any policies. The Chair advised that discussions had been taking place and ICVs would be informed when policy changes related to custody had taken place.
