PANEL MEETING WELCOME

- 1.1 The Governance Manager welcomed the Panel to the meeting and advised that that Natalie Hill had been elected as Chair and Steve Richards as Deputy Chair.
- 1.2 The Police and Crime Commissioner welcomed the High Sheriff of Dorset, Callum Bremner, to the Panel meeting. The High Sheriff graciously shared his thoughts on volunteering and expressed his gratitude to those who give their time in service.

APOLOGIES FOR ABSENCE

2. Apologies were received from Mr J Hoyland.

MINUTES AND MATTERS ARISING

- **3.1** The draft minutes of the meeting held on 28 April 2025 were approved as a true and accurate record.
- 3.2 The Chair provided information regarding the actions on the Action Log and confirmed that all four actions from the previous meeting had been completed. Action 2024-015 relating to the requested Niche change was reassigned to the Custody Support Manager. The other 3 we will continue to track moving forward.

VISIT REPORT

- **4.1** The Chair highlighted key data from the visits during Quarter 1 1 April 2025 to 1 July 2025.
 - Sixty-five people were visited out of the 173 detained. Eighty visits were offered in total, and fifteen detainees refused. Eighty-one percent were happy to speak with the ICVs which was positive.
 - Of the detainees that were not spoken to, 53 (66.3%) were asleep at the time of the visit and 15 (8.7%) refused a visit.
 - Visits were conducted on each day of the week, covering a broad range of time slots. In Bournemouth, visits occurred during all but one time slot, and in Weymouth, all but two. The Chair expressed appreciation to the visitors for their commendable efforts and achievements.
 - Entry to custody suites occurred within five minutes for all but two visits this quarter. It was noted that on one of these occasions, the delay resulted from a new detention officer who was attempting to be overly helpful.
 - The average duration of visits has decreased to between 1 and 1 1/2 hours. This reduction is attributed to new ICVs and staff members becoming more familiar with the process.
 - The number of late inspector reviews increased this quarter to fourteen, up from nine. This rise had been anticipated due to resource constraints on a reduction of the overnight custody inspector.
 - The number of late 30-minute observation checks decreased from six to four this quarter, and no late 60-minute observation checks were recorded.

CUSTODY VISIT REPORTS

4.2 Weymouth 11 April 2025 Report 1313

The ICVs reported that a detainee had requested snacks; however, none were available, and stocks of hot meals were noted to be very low. The escorting officer advised that an order was placed on 23/03, but it had not yet been delivered. The Custody Manager confirmed that the food order has since arrived. It was also noted that food ordering is now managed by the team, rather than a single individual.

4.3 Bournemouth 15 April 2025 Report 1320

The ICVs reported that M1 is currently out of use due to a potential ligature point, and the trim on the bottom of a door remains broken.

The Custody Manager will check with Estates regarding the ligature point. The fault with the door remained outstanding and would likely be for some time.

Action - Custody Support Manager to check with Estates re ligature point

4.4 Weymouth 17 April 2025 Report 1329

ICVs noted a significant delay between arrival in custody for two detainees and the recorded time of detention. There were also some reviews carried out significantly early with no rationale on the log. The Governance Manager advised recording of early reviews should continue. The Custody Manager agreed that the ICVs should question, monitor and report early reviews.

ICVs also raised a query regarding a vulnerable adult for whom the Custody Sergeant had determined that an Appropriate Adult (AA) was not required. The Custody Manager advised that a detainee can be vulnerable but does not always require an

AA. This is a decision made by the Custody Sergeant, but there should be a rationale on the log.

4.5 Bournemouth 22 April 2025 Report 1338

ICVs noted that a detainee had prescribed post-stroke medication. Medication was requested at 11:11 but not administered until 13:58. Clarification was requested regarding the reason for the delay.

Action – Custody Support Manager to check with HCP and report back

4.6 Weymouth 16 May 2025 Report 1389

During this visit the ICVs reported a log entry labelled 'Hist Review' and queried the meaning with the inspector. He stated that he was not aware of the meaning or purpose of this entry.

Action - Custody Manager to provide an explanation

4.7 Bournemouth 4 June 2025 Report 1416

The ICVs reported that the custody log was unclear regarding the arrival time of the AA. The log also indicated that strip search was required, and that the rationale would follow; however, while it was evident the strip search had taken place, no notes or rationale were recorded on the log. Custody Support Manager advised that the Custody Sergeant was asked to update the log, which has since been actioned.

4.8 Weymouth 14 June 2025 Report 1438

The ICVs noted that the location of the strip search had not been recorded in the custody log. They also reported a delay of over an hour between the DP's arrival into custody and the authorisation of detention. The Custody Manager advised us that the delay was due to an incident involving four people. All individuals arrived in custody at the same time for a significant offence.

4.9 Weymouth 24 June 2025 Report 1448

ICVs noted that a detainee wished to make a complaint regarding his treatment during the interview and at the time of arrest. The Custody Sergeant stated that he was unsure how to proceed with this information. The Custody Support Manager advised that the Custody Sergeant has since received refresher training in handling complaints.

4.10 Bournemouth 1 July 2025 Report 1464

During this visit the ICVs expressed concern that a juvenile detainee had been in custody for over 17 hours. The Appropriate Adult Service (TAAS) had been unable to attend on two occasions. Clarification was requested on whether an explanation was sought and if assurance was received that the response was satisfactory. The Custody Support Manager advised that this was a complex case and has been reported as a service failure.

4.11 Bournemouth 1 July 2025 Report 1464

The ICVs reported that a detained person had been taken to hospital after losing consciousness and appeared confused upon their visit. They expressed concern about the DP's demeanour. The custody log noted cuts and bruising to the face; however, ICVs observed an additional bruise near the temple, not recorded on the log. The Custody Support Manager advised that a hospital fit note stated that the detainee had

been examined and was fit to be detained. They had been seen by a Health Care Professional (HCP) on return and on Level 2 observations until he settled. The solicitor had no concerns about the detainee's presentation for interview after some sleep. Ketamine had been used by detainee prior to incident.

ANY OTHER BUSINESS

5. The Police and Crime Commissioner thanked the High Sheriff for his attendance at the Panel. The High Sheriff stated that he had found the discussions interesting and had been impressed with the collaborative nature between the ICVs and Dorset Police.
