PANEL MEETING WELCOME

1.1 The Chair of the Panel welcomed all attendees to the meeting.

APOLOGIES FOR ABSENCE

2. Apologies were received from Mr S Richards, Mr G French, Mrs L Beesley, Mr A Harrold and Superintendent G House.

MINUTES AND MATTERS ARISING

3.1 The draft minutes of the meeting held on 21 July 2025 were approved as a true and accurate record. Subject to an amendment to show the 30-minute 'late' observations more proportionately.

Action: Governance Manager

3.2 The Chair provided information regarding the actions on the Action Log and confirmed that all actions from the previous meeting had been completed.

VISIT REPORTS

4.1 The Chair highlighted key data from the visits during Quarter 2 - 1 July 2025 to 30 September 2025.

- 89% of detainees were happy to speak with the ICVs which was positive.
- Of the detainees that were not spoken to, 19.4% were asleep at the time of the visit and 3.8% refused a visit.
- The report had shown that visits although covering every day of the week, had not been conducted on every day of the week, but following a challenge from an ICV this was reviewed during the meeting and amended to show visits had actually occurred in every time slot. The Chair expressed appreciation to the visitors for their commendable efforts and achievements.
- The majority of the visits saw entry within 5 minutes, only one after 15 minutes.
- Most visits were completed in under 2 hours.

Recurring Themes

- There was a discussion regarding late Inspector Reviews. It was noted that while the number of reviews requiring a rationale, or missing a rationale, had decreased during the last quarter, this quarter there had been an increase in the number of occasions where detainees were not informed of a review on waking.
- There was also a discussion regarding late 30-minute observations. The rationale for these, whether provided or missing, was recorded. It was noted that there had been a significant increase in late observations this quarter. The reason for this rise is not yet clear, but it will continue to be closely monitored.
- Late 60-minute observations were also reviewed. There was only one instance reported this quarter, and it was noted that no rationale had been provided for this delay.

CUSTODY VISIT REPORTS

4.2 **Weymouth 4 July 2025 Report 1477 – RW & HJ**

ICVs reported that the Qur'an was being stored in a drawer, though not in the top one. They noted that signage previously placed on the front of the drawer in Weymouth was no longer there. The Custody Support Manager confirmed that she would check this matter.

Action: Custody Support Manager

Some late reviews were also identified, and the rationale for these delays had not been recorded. The Custody Support Manager agreed to issue a reminder to ensure that reasons for any late reviews are properly documented in future.

Action: Custody Support Manager

In relation to detainees 7683 and 7684, there was a delay between the time of arrest and arrival at custody. The Custody Support Manager explained that this was due to travel time, as the detained person had been arrested in the north of the county, causing the delay.

It was further noted that an Appropriate Adult (AA) had been advised by CJLD in one instance but was not called, and no explanation for this was recorded in the custody log. The Custody Support Manager explained that an AA had not been considered necessary in that case but agreed a clear rationale should be documented in the log when such decisions are made.

4.3 Bournemouth 21 August 2025 Report 30 – HJ & AB

The ICVs reported that they were not accompanied upon entry to the custody suite and asked whether this was appropriate, as they had understood they should be escorted. The Custody Manager advised that staff are briefed to provide an escort where possible. However, if staff are busy and recognise the ICVs, they may allow entry via the buzzer on some occasions. The Governance Manager explained that if it is recommended that ICVs are escorted in, they should continue to report instances where this does not occur.

A question was raised regarding reviews undertaken whilst the detainee was asleep. It was noted that a check was missing, and the same detainee was not informed of the review. It was suggested that detention officers may be able to advise detainees of their sleeping reviews.

Action: Custody Support Manager to provide clarification.

The log indicated that the detainee was awake five minutes before and five minutes after their review, although the Inspector had noted that the detainee was asleep during the review. The Custody Manager advised that the custody staff should challenge the Inspector's record. The ICVs, however, noted that it was the previous team who had been on duty at the time.

4.4 Bournemouth 29 August 2025 Report Paper Copy – HJ & CS

ICVs noted a late review. The log indicated that the detainee was awake, raising the question of whether they should have been informed about the review as soon as possible. Additionally, the individual had two separate log entries, at the time the custody sergeant advised that the detainee had been bailed and then rearrested, resulting in a second log entry.

There was a significant delay before an AA attended, despite the risk assessment identifying that an AA was required. It was also noted that the detainee had been given two pencils; the first had been taken away, and the detainee was subsequently given a second pencil, prompting questions about the reason for this.

4.5 Bournemouth 24 September 2025 Report 36 – AM & NH

The ICVs had to abandon their visit due to excessive waiting time. The Custody Manager provided an explanation for potential delays, citing factors such as staff handovers and short staffing.

ANY OTHER BUSINESS

5. Update from the Chief Inspector – Death in Custody

The Chief Inspector provided an update regarding the ongoing investigation into the recent death in custody.

An ICV asked about the use of detection alert mattresses implemented in some other forces. The Chief Inspector advised that there were no plans to introduce these in Dorset as it was felt that staff can become overly reliant on the devices, which may

lead to complacency in carrying out regular checks. Additionally, there have been instances where alerts have been ignored due to false errors. It was also noted that the high cost of these mattresses a further factor in the decision not to adopt them at this time.
