- 3.3** The ICVs had noted that there had been recurring issues with the attendance of Appropriate Adults via the Appropriate Adult Service. The Custody Support Manager advised that the Force were aware the organisation had been struggling to recruit sufficient volunteers for the role and a meeting was due to take place with TAAS to discuss the issue. As TAAS are an OPCC commissioned service, the Director of Operations would speak with the relevant Policy Manager to share the feedback and ensure the OPCC had done all they could to assist.

## **VISIT REPORTS**

- 4.1** The Deputy Chair highlighted key data from the visits during Quarter 3 - 1 October 2025 to 31 December 2025.
- 86% of detainees were happy to speak with the ICVs.
  - Of the detainees that were not spoken to, 22.6% were asleep at the time of the visit.
  - The report had shown that visits had covered every day of the week, but not every time slot had been achieved but that was not unusual in the winter months.
  - All visits saw entry within 5 minutes and the Force were thanked.
  - Most visits were completed in under 2½ hours.

### Recurring Themes

- The Governance Manager talked the panel through the recurring themes, late inspector reviews continued to be reported regularly, and the detainee not being informed when a review had taken place whilst they were asleep.
- In relation to late 30-minute observations, 6 of the 8 occurrences had related to one detainee which appeared unusual. The Governance Manager would provide the Custody Support Manager with those details for further investigation.

## **CUSTODY VISIT REPORTS**

### **4.2 Bournemouth – 2 October 2025 – Report 1520 – HJ & SR**

ICVs noted that in relation to detainee 9968 the whiteboard had not correctly shown what legislation the detainee had been held under. Initially they had been held under PACE but there had been a change in the status to being held under immigration, the whiteboard had still shown PACE. The Custody Support Manager advised that she would check to assess if this had been an anomaly or was an issue with Niche.

**Action: Custody Support Manager**

The ICVs had also noted that the log for the same detainee had not shown a strip search had taken place but no cell number had been recorded.

### **4.3 Poole – 4 November 2025 – Report 46 – CS & NH**

The ICVs reported that the log for a detainee indicated that the detainee had not been informed of a review that had taken place when they were sleeping despite opportunities to do so. The Force accepted that this had been human error. There had also been confusion regarding the time of an observation visit and whether it had occurred at 00:05 or 00:53, the latter of which would see 23 minutes late. It was

confirmed that the correct time had been 00:53, but the detainee had gone onto hourly observations, so it had not been late.

#### **4.4 Weymouth – 12 November 2025 – Report 48 – HJ & RW**

ICVs visited a vulnerable adult male who presented as distressed, shaking and had clearly struggled with another detainee who had been banging on a nearby cell door. The ICVs had been concerned about his demeanour and queried whether an Appropriate Adult had been contacted, which they had.

On reviewing the log of another adult male, they noted that the first inspector review had taken place 52 minutes early. TCI Liddicott explained that the preference would be for a face-to-face review with the detainee, so efforts were made to achieve that. It was accepted that early inspector reviews would be beneficial for the detainee as it could potentially result in more occurring. As a result, ICVs would no longer record when inspector reviews are early. The Governance Manager would ensure this was shared with the ICVs.

#### **4.5 Weymouth – 25 November 2025 – Report 51 – AM & GF**

Following the ICVs querying aspects of the log for a detainee, the Custody Sergeant had overheard and identified that there had been a human error, and an entry had been incorrectly recorded on the log.

#### **4.6 Poole – 4 December 2025 – Report 54 – AB & NH**

On arrival at the suite the ICVs had overheard a comment by a member of staff on the intercom and perceived that comment to be unwelcoming. This was raised at the time and an apology offered and accepted. ICVs had not only been disappointed to hear the comment but were saddened that such comments had been made in the custody environment when staff should be behaving professionally. ICVs received assurances that this incident was not indicative of the attitude of staff as a whole but related solely to the individual concerned in the given context.

During the same visit ICVs identified that some of the Qur'ans had torn spines and could potentially need replacement. The Custody Support Manager informed the Panel that the Qur'ans had been replaced.

#### **4.7 Bournemouth – 28 December 2025 – Report 61 – CS & JH**

During this visit ICVs had viewed the custody log of a detainee being held in cell F5. They had queried whether CJLD should have been contacted earlier due to the detainee's behaviour and declaration of depression. The Custody Support Manager explained that it had been necessary to wait for the detainee to sober up before they could be referred. She added that there was no CJLD service overnight, although they had an out of hours telephone number should they require background on any detainee. CJLD had been contacted in the morning.

### **ANY OTHER BUSINESS**

#### **5.1 Blood Sample in Fridge**

On a visit to Bournemouth during the current quarter, ICVs had found a blood sample in the fridge. It appeared to have been stored there for around six days, but an

explanation could not be provided. The Custody Support Manager would issue a reminder to all staff that blood samples are not to be stored in any fridges.

## **5.2 Thanks to Weymouth Custody**

Two ICVs had undertaken a visit to Weymouth shadowed by the High Sheriff. Although there had not been any detainees being held, the staff had given the High Sheriff a comprehensive tour. The ICVs wanted to express thanks to the staff involved.

## **5.3 Entry to Bournemouth**

ICVs have experienced issues gaining entry to custody when going through the main reception at Bournemouth. The Custody Support Manager and the Chief Inspectors advised ICVs to use the same access as they do for out of hours visits.

## **5.4 Update from the Director of Operations**

The Director of Operations provided an update regarding the announcement of the abolishment of PCCs in 2028.

He reassured the Panel that it was expected that responsibilities related to the administration of an ICV Scheme would pass to the future body.

However DP was not informed of Review until 13.15, despite other interactions with detainee in the intervening period. DP stated he hadn't been offered food. Custody Log shows no record of food/meals, just fruit powder sachet. Subsequently we've been told by DO that DP has been seen by HCP re injuries and meds.
<b>Custody Officer response to issues raised about this detainee</b>	Insp 901 dealt with our queries above as Custody Officer still very busy. All matters noted and will feed back to custody officer and team.
