| 1923 | 01/04/19 | Victim's Lawyer/Complainant Advocate | The Commissioner agreed to pilot a Complainant Advocate / Victim Liaison within the court arena. The pilot scheme would aim to ensure that the voice of victims is heard by providing an assertive advocacy and support service to individual victims through the court process, i.e. before, during and after trials, dependent on the needs of the victim. This consists of provision of a physical presence within the court arena, outside the court room; providing vulnerable victims (and witnesses) with face-to-face accessibility to a Complainant Advocate, who will be there to provide information, make referrals to other support agencies as required and ensure victims are aware of their entitlements under the VCoP. | Link to News Article on PCC Website |
| 1924 | 01/04/19 | RETROSPECTIVE ENTRY Agreement to fund the Pop-up Youth Clubs project. | The PCC agreed to fund Pop-up Youth Clubs £14,650 to target areas of need in the Poole Area, such as the Dolphin Centre and Bus Station and deliver interventions, through effective engagement, to youths potentially presenting criminal and anti-social behaviours. The scheme will be led by Borough of Poole youth work professionals, but also with a Police presence. | |
| 1925 | 16/04/19 | SSE Contract for Groundworks | The Commissioner agreed to the signing of the contract for SSE to undertake groundworks at Force Headquarters, Winfrith as part of the upgrading of site equipment. | |
| 1926 | 16/04/19 | Lease of Communications Site | The Commissioner agreed to the signing of the lease for the communications site at Eddgardon Hill South, West Compton | |
| 1927 | 22/04/19 | RETROSPECTIVE ENTRY Agreement to fund Hotel Watch Videos | It was agreed to relaunch the Hotel Watch, involving Dorset Police Communications to create the videos, jointly funded by OPCC and Coastal BID. | |
| 1928 | 06/05/19 | Police Staff Council Funding | The Commissioner agreed to extend the current funding arrangements for the Police Staff Council at the cost of £1,095. | |
| 1929 | 10/05/19 | Sherborne Area Roadsafte | To provide funding of £3,000 to Sherborne Area Roadsafte to help them design a campaign to raise awareness of road safety for 3000 children and their families in Sherborne and the surrounding villages, the campaign is highlighting how speeding is a major cause of death and injury among the young, with the risk rising as children reach secondary school age. | |
| 1930 | 10/05/19 | Trauma Recovery Resources Programme | To provide funding of £3,000 to Trauma Recovery Resources Programme to enable them to support vulnerable adults over the age of 16, who suffer from the enduring consequences of childhood abuse. | Trauma Recovery Resources |
| 1931 | 13/05/19 | RETROSPECTIVE ENTRY Agreement to fund the CAROLE Co-ordinator role. | The PCC agreed to fund £50,000 for a CAROLE (Children At Risk Of Likely Exploitation) Co-ordinator on request from Dorset Council (host of pan Dorset multi-agency exploitation work) to work across all agencies to introduce processes and systems to enable multi-agency effective risk identification, information management and tasking. | |
| 1932 | 31/05/19 | Agreement to increase the Driver Awareness Course Fee | The Commissioner agreed to increase the fee for the Driver Awareness Course from £110 to £120 from 1 June 2019. | |
| 1933 | 06/06/19 | Disposal of Former Police House | The Commissioner agreed to the disposal of the former police house at 15 Osborne Road, Bridport | |
