

# FREEDOM OF INFORMATION REQUEST REFERENCE NO 2022-026

Your request has now been considered under the Freedom of Information Act 2000 (the Act) and we provide our response below.

## You asked for:

- 1. A) Please would you send me through all documents, reports and analysis carried out by the force and sent to the PCC pertaining to the rebranding of the Dorset Police Force's Rural & Wildlife Crime Team to the Dorset police rural crime team in the past 12 months.
  - B) Would you also send me all correspondence made in the past year surrounding this rebranding between the PCC and Dorset police leaders Chief Constable **Scott Chilton**, Deputy Chief Constable **Sam de Reya**, Assistant Chief Constable **Steve Lyne**, ACO **Jo Mosley**, Director of Legal, Reputation and Risk **Mike Stamp**, Head of Crime, Detective Chief Superintendent **Ben Hargreaves** and your head of Operations Chief Superintendent **Matt Lawler**, Bournemouth, Christchurch and Poole Local Policing Commander Chief Superintendent **Mark Callaghan**, County Local Policing Commander Chief Superintendent **Richard Bell**, Head of Corporate Development Chief Superintendent **Caroline Naughton** and PC **Claire Dinsdale**.
  - C) Finally, please would you confirm if the PCC knows and would share the new structure of the Dorset police rural crime team including staff numbers compared with the Dorset Police Force's Rural & Wildlife Crime Team and who is to be put in charge of it?
- 2. A) Would you please send me all correspondence related to rural and wildlife policing made in the past 12 months between PCC David Sidwick and Chief Constable Scott Chilton, Deputy Chief Constable Sam de Reya, Assistant Chief Constable Steve Lyne, ACO Jo Mosley, Director of Legal, Reputation and Risk Mike Stamp, Head of Crime, Detective Chief Superintendent Ben Hargreaves and your head of Operations Chief Superintendent Matt Lawler, Bournemouth, Christchurch and Poole Local Policing Commander Chief Superintendent Mark Callaghan, County Local Policing Commander Chief Superintendent Richard Bell, Head of Corporate Development Chief Superintendent Caroline Naughton and PC Claire Dinsdale.
  - B) Please would you also send me all correspondence related to rural and wildlife policing made in the past 12 months between PCC David Sidwick

and West Dorset MP Chris Loder, including any issues related to birds of prey and raptors.

Such correspondence can include but are not exclusive to: in-person and online meetings, letters and emails.

C) Please would you also confirm how many in-person meetings have taken place between Dorset PCC David Sidwick and the above eleven officers and West Dorset MP Chris Loder respectively. Once identified, please supply the minutes of each meeting, with the date and which of the eleven officers were present and the MP.

Your request for information has been considered under the Freedom of Information Act 2000 (the Act) and our response can be found as follows:

- 1. A) No information held.
  - B) Information attached.
  - C) No information held. \*As the request is for information relating to a team for which the Chief Constable has responsibility for, we believe Dorset Police would be able to provide the information you have requested.
- A) & B) Information attached at \*\*Appendix A and \*\*Appendix B
   No information held.

\*It should be noted that the Freedom of Information (FOI) Act 2000 covers all recorded information held by a public authority. The Act does not cover information that is in someone's head. If a member of the public asks for information, then we only have to provide information we already have in recorded form. We do not have to create new information or find the answer to a question from staff who may happen to know it.

\*\*The Office of the Police and Crime Commissioner are unable to provide you with full details, therefore redactions have been applied virtue of Section 30 (1) (a) (b) (c) Investigations and Section 40 (2) Personal information.

The Freedom of Information Act 2000 creates a statutory right of access to information held by public authorities. A public authority in receipt of a request must, if permitted, state under Section 1(a) of the Act, whether it holds the requested information and, if held, then communicate that information to the applicant under Section 1(b) of the Act. The right of access to information is not without exception and is subject to a number of exemptions which are designed to enable public authorities, to withhold information that is unsuitable for release. Importantly the Act is designed to place information into the public domain. Information is granted to one person under the Act, it is then considered public information and must be communicated to any individual, should a request be received.

## **DECISION**

Your request for information has been considered and I regret to inform you that the Office of the Police and Crime Commissioner for Dorset cannot fully comply.

This letter serves as a Refusal Notice under Section 17 of the Freedom of Information Act 2000. Section 17 of the Act provides: (1) A public authority which, in relation to any request for information, is to any extent relying on a claim that information is exempt information must, within the time for complying with Section 1(1), give the applicant a notice which:

- (a) States the fact,
- (b) Specifies the exemption in question, and
- (c) States (if that would not otherwise be apparent) why the exemption applies.

## **REASONS FOR DECISION**

The reason that we are unable to provide you with this information is covered by the following Exemption: Section 30 (1) (a) (b) (c) Investigations Section 40 (2) Personal Information Section 40 is an absolute class-based exemption, therefore does not require me to articulate the harm or conduct a public interest test. To disclose the information would significantly increase the risk of individuals being identified which would breach principle 1 (lawfulness, fairness and transparency) of the Data Protection Act 2018. Section 30 is a qualified class-based exemption, as such requires a public interest test to be conducted.

## **Public interest test**

## **Factors favouring disclosure**

Disclosure of the redacted information would adhere to the basic principles of openness and transparency, creating a more informed public on the investigations carried out by Dorset Police

## Factors against disclosure

Disclosure of the redacted information would make public, specific details recorded for the purpose of an investigation. Making these details public would undermine the investigation process, potentially diminishing any person's right to a fair trial, undermining any future proceedings that may arise.

### **Balance test**

Whilst there is a public interest in the investigations carried out by Dorset Police and a full disclosure would enhance public confidence that the force take all investigations seriously and conduct them thoroughly. Dorset Police are tasked with the prevention and detection of crime, the investigations conducted are crucial to this, therefore any disclosure which would undermine this process must not be made. It is for this reason I believe balance lies in favour of non-disclosure at this time.

Dorset Police has responded robustly to allegations that a White-tailed Sea Eagle had been deliberately poisoned and killed by unknown persons. As a result of the sea eagle being found dead on land in the North Dorset area, our team has carried out a full and proportionate investigation under Section 1 of the Wildlife Countryside Act 1981 in conjunction with Natural England, National Wildlife Crime Unit, the RSPB and the Roy Dennis Wildlife Foundation to identify any offences and perpetrators who may be responsible. As you can imagine detecting the deliberate poisoning of a bird of prey is extremely difficult without local intelligence and information to support the investigation. GPS data provided information that over an 11-day period the White-tailed Sea Eagle spent time across a multitude of locations in the North Dorset area. Despite working with experts, we have been unable to confirm deliberate intent to kill this beautiful bird or identify potential offenders. A detailed examination and tests have been carried out on the bird, which were inconclusive, and it has therefore not been possible to confirm that any criminal offence has been committed. While high levels of brodifacoum were detected, it has not been possible to establish whether this was as a result of a deliberate act or due to secondary rodenticide poisoning. We would still encourage anyone with new information to come forward to support enquiries.

The Force is committed to keeping everyone in our county safe, including our wildlife, which brings so much to our beautiful countryside and our communities. As part of the police uplift programme and working together with the Office of the Police and Crime Commissioner we have reviewed our Rural Crime Strategy for the county and allocated increased numbers of officers to the Rural Crime Team to tackle the issues that matter. This includes all aspects of rural, wildlife and heritage-related crime. We will continue to work closely with many different partner agencies in relation to these issues. As always, should any new information be received in relation to this investigation, this will be considered.

We want to make it clear that we take any and all potential wildlife offences seriously and will act to prevent and detect offences wherever possible.

A mini update	from us
-	<b>plift</b> - You may have been told that we are due an uplift of 4 PCs at some point but I presume likely 2021 or into 2022.

- Hare & deer coursing continues and the intimidation tactics with some farmers having their new Spring Barley crops completely run over by coursers or gates rammed. There is still a lot of under reporting despite all the work we do, some farmers just give up as don't see 'action'. It's very hard with the staff limitations especially at night and especially over a wide rural area. Blandford up the A354 towards Salisbury continues to be hit, as well as Almer and Winfrith - Dorchester areas. Catching coursers at the time is very tricky. To get to court so all the penalties and CBOs kick in starts with the farmer making a witness statement which some are clearly reluctant to do. However as you know we try all angles to disrupt them without identifying any farmers. Nationally we are still very much part of 'Op Galileo' the national police response to coursing. We have once a month Op Galileo patrols where we brief NPT officers detached for the op. Clearly &I try to patrol where we can the rest of the time and put patrol requests out to NPTs and Op units. Our firearms units have secondary taskings to patrol the poaching/coursing hotspots however the areas are large and they can be called away of course. We continue to ask farmers to build land defences where they can to stop them getting in but this can be tricky around field boundaries, bridleways and of course if a metal fence then the criminals simply cut the fencing. has produced a guide for us to use with farmers that all the NPTs in rural areas have.
- Farm crime prevention organised thefts of plant continues in the UK One of the best things we can do is continue to roll out the Stop That Thief scheme, which is 'owned' by a committee of farmers and branch members of NFU. This is in progress. This is basically funds provided off the back of the scheme to buy intruder alarm kits (wireless type dial up alarms) for the farm buildings so the farmer is alerted at the time. All other methods out there, like locking, marking, etc all great but won't stop all organised criminals or rely on police locating the stolen kit in the first place. We want to prevent the thefts in the first place!

- OCGs We have a particular group in Dorset we focus on, they are not just rural crime but other matters too. There is a deal of work we have done on them and continues. One member recently found guilty of 5 charges and we put in a new CBO application to try and disrupt his offending. There are other groups of handlers too who we have been working on with A&S.
- Livestock thefts thankfully only one larger sheep theft (43) last November in Dorchester but for a repeat victim of such. Really frustrating as current livestock system has so many loopholes. However we get reports of the odd 5 ewes being stolen elsewhere.
- Livestock attacks by dogs I try not to use 'worrying' term as it doesn't quite express the issue!
   Unfortunately these occur every month all over and normally it is your every day Mrs Miggins and her pooch whom she didn't think would ever do such a thing. A recent offender was taken to court by our NPT rep in North Dorset and fined <a href="https://www.bournemouthecho.co.uk/news/19288372.woman-court-fatal-dog-worrying-attacks-dorset/">https://www.bournemouthecho.co.uk/news/19288372.woman-court-fatal-dog-worrying-attacks-dorset/</a>
- Wildlife Crime bat roost destruction cases, protected species/habitats, raptor/birds of prey poisoning and shooting esp in NE Dorset so some careful work ongoing there as unfortunately a handful of the perpetrators are also our gamekeepers that we work with on rural crime/poaching matters. Recent reports really a concern, especially the use of highly toxic poisons. This is not great when we also have our Osprey project in Poole & Purbecks and recent White Tailed Sea Eagles been released and they have been in NE Dorset so any such illegal killing will be national news. I sit on several national groups so after one of our criminal cases is over, I shall be approaching landowners/estate owners and keepers in person for their support on this matter as well as dangers of secondary rodenticide use. Some visits have already been done after a series of dead birds of prey since last March coinciding with lockdown. In confidence as we are not doing publicity until the criminal cases are over.
- **Heritage Crime** We have a few reports now and then of illegal metal detecting. A little damage or graffiti/ASB at schedule monument sites or listed buildings.
- Dog Theft Although a force wide issue, not just on farms of course, I try do what I can. In a working group with D&C and others. Our Force Dog Legislation Officer & Dog Handler has also purchased some dog scanners for each section, as well as the 5 we got for rural NPT a few years back. There has been a lot of publicity and MP/Government comment as you probably know. It is definitely more a fear of theft and some areas of UK worse than others but a lot of non reporting. Figures are a bit skewed as many reports are actually civil matters between ex partners so the actual stranger thefts are lower. However 3 stolen dogs a year is three too many to those families and I. There is lots of work ongoing nationally on this, with a joined up approach including getting the communications right to reduce fear and provide good prevention advice. Our website already has lots of advice on this.
- Linked to this is some criminals are now simply breeding puppies and making £1000 a pup and selling off Gumtree and Pets 4 Homes. It is the local Authority remit to look in to licencing aspects. We recently invited a BCP Council officer to our 'PCG' meetings to try and share intelligence better and is driving a warrant at present regards one character with BCP and RPSCA on board so we can get in to the address.
