## Minutes/action logs from the most recent VAWG/RASSO scrutiny meeting the OPCC runs/attends.

Information cannot be disclosed. This information is exempted by Section 40 (2) of the Freedom of Information Act – Personal Information.

The exemption relates to any requests for information in respect of third parties, where disclosure of such information would breach the following Data Protection principles regarding personal data:

- 1. It should be fairly and lawfully processed
- 2. Processed for limited purposes
- 3. Processed in line with the data subjects' rights
- 4. Secure

The Office of the Police and Crime Commissioner holds scrutiny meetings relating to Violence Against Women and Girls (VAWG), which also cover Rape and Serious Sexual Offences (RASSO) cases. The minutes and action logs from these meetings contain information of a sensitive nature and include personal data from which individuals may be identified.

As such, this exemption applies because the information that you are requesting refers directly to living individuals, and their personal information. Those drafting the Act clearly considered that the disclosure of such information would in most cases risk undermining individual's rights to privacy and those rights still stand in these circumstances.
